In consideration of the services of The Palm Tree House in association with Escape Haven Bali, their agents, owners, officers, volunteers, participants, employees, service suppliers and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as "The Palm Tree House in association with Escape Haven Bali"), I hereby agree to release, indemnify, and discharge The Palm Tree House in association with Escape Haven Bali, on behalf of myself, my children, my parents, my heirs, executors, administrators, assignees, personal representatives and estate as follows:

A. I acknowledge that the sport of surfing and traveling entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. My participation in all retreat activities is purely voluntary, and so expressly agree to assume the risk of injury or damage while participating in all activities during my stay with The Palm Tree House in association with Escape Haven Bali and are not grounds for a refund or discount.
